## TAX EFFICIENT GIVING

If you are a UK tax payer, please complete the Gift Aid declaration below, to allow the Bar Convent Trust to reclaim tax on your gift, thus increasing the value of your donation at no additional cost or inconvenience to yourself.

If you Gift Aid your donation, the Heritage Project will receive an additional 28p for every pound you have given. This includes a separate government supplement of 3p on every pound you give up to 5 April 2011.

For example: a regular donation of £23 per month, over three years, would currently give the Heritage Project £1,059.84, but only cost a basic rate tax payer £828.

If you are a higher rate tax payer, you may also reclaim the difference between the basic and higher rates of tax eg 20% on the gross value of your gift (before the government supplement).

A single gift of £1000 to The Heritage Project after tax reclaim and the government supplement is currently worth £1,282. The benefit to the higher tax payer donor is £250. Therefore a £1,282 gift (£1000 donation cost) has cost the donor £750. This applies to all sizes of charitable gifts, both single and regular donations.
